- 2. Whether the Firm is an individual or partnership (declaration on the letterhead about the status of the firm).
- 3. Name of the Contractor/Firm, Address, Tel./Mobile No. and E-mail id (declaration on the letterhead of the bidder).
- 4. The Bidder should not have been blacklisted by any State/Central Govt. Office/PSU (declaration on the letterhead of the bidder).
- 5. Banker's name, Address & Account number (declaration on the letterhead of the bidder).
- 6. The Contractor/Firm should submit self attested copy of PAN.
- 7. The Contractor/Firm should submit self attested copy of upto date GST Registration.
- 8. The Contractor/Firm should submit self attested copy of Trade License.
- 9. The Contractor/Firm should submit self attested copy of up to date Labour license certificate from the appropriate authority along with the tender.
